




Number of Terrorist Incidents Took Place in Bangladesh by Division in Year 2020.


Year 2020 in Numbers




People Arrested by Different Category 2020

Prosecution/Execution

A Dhaka court on 20 January 2020 sentenced 10 members of the banned militant outfit Harkat-ul-Jihad al-Islami (HuJI) to death in a case filed over a bomb attack on a rally of the Communist Party of Bangladesh (CPB) in 2001. The attack, in Dhaka, left five people killed. The convicts were Mufti Moin Uddin Sheikh alias Abu Jandal, Arif Hossain Sumon, Maulana Sabbir Ahmed, Shawkat Osman alias Sheikh Farid, Jahangir Alam Badar, Mohibul Muttakin, Aminul Mursalin, Mufti Abdul Hai, Mufti Shafikur Rahman and Nur Islam.

• On February 19, A Jhalakathi court has sentenced two men to life term imprisonment in a case filed over the series of bomb blasts across Bangladesh in 2005. The two were Ziaur Rahman, son of Younus Molla from Bikna area of Jhalakathi, and Farid Howladar, son of late Mosharrof Howladar from Keota village of Rajapur upazila.



Prosecution/Execution

A Speedy Trial Tribunal in Rajshahi District of Rajshahi Division on March 15, handed down death sentences to four cadres of banned Islamist outfit Neo-JMB for killing a Hindu priest in Panchagarh District of Rangpur Division in 2016. The death-row convicts were Jahangir Hossain alias Rajib Gandhi, Alamgir Hossain, Ramjan Ali and Rajibul Islam Molla. Among the death-row convict, Rajibul Islam was absconding. The tribunal also acquitted three other accused in the case, Harej Ali, Khalilur Rahman and Mohammad Rana, as allegations brought against them were not proved.

A court in Sylhet on December 13 sentenced Abdul Aziz alias Hanif, a leader of the banned militant outfit (JMB), to life term imprisonment in a case filed over a series of bomb blasts in Sylhet city's Kadamtali Bus Terminal in 2005. On 17 August 2005, as part of the countrywide series bomb blasts by JMB, bombs went off in 13 places of Sylhet District including the bus terminal, Sylhet court and other important places. In the blasts, no one died in Sylhet but 15 people were injured.
