

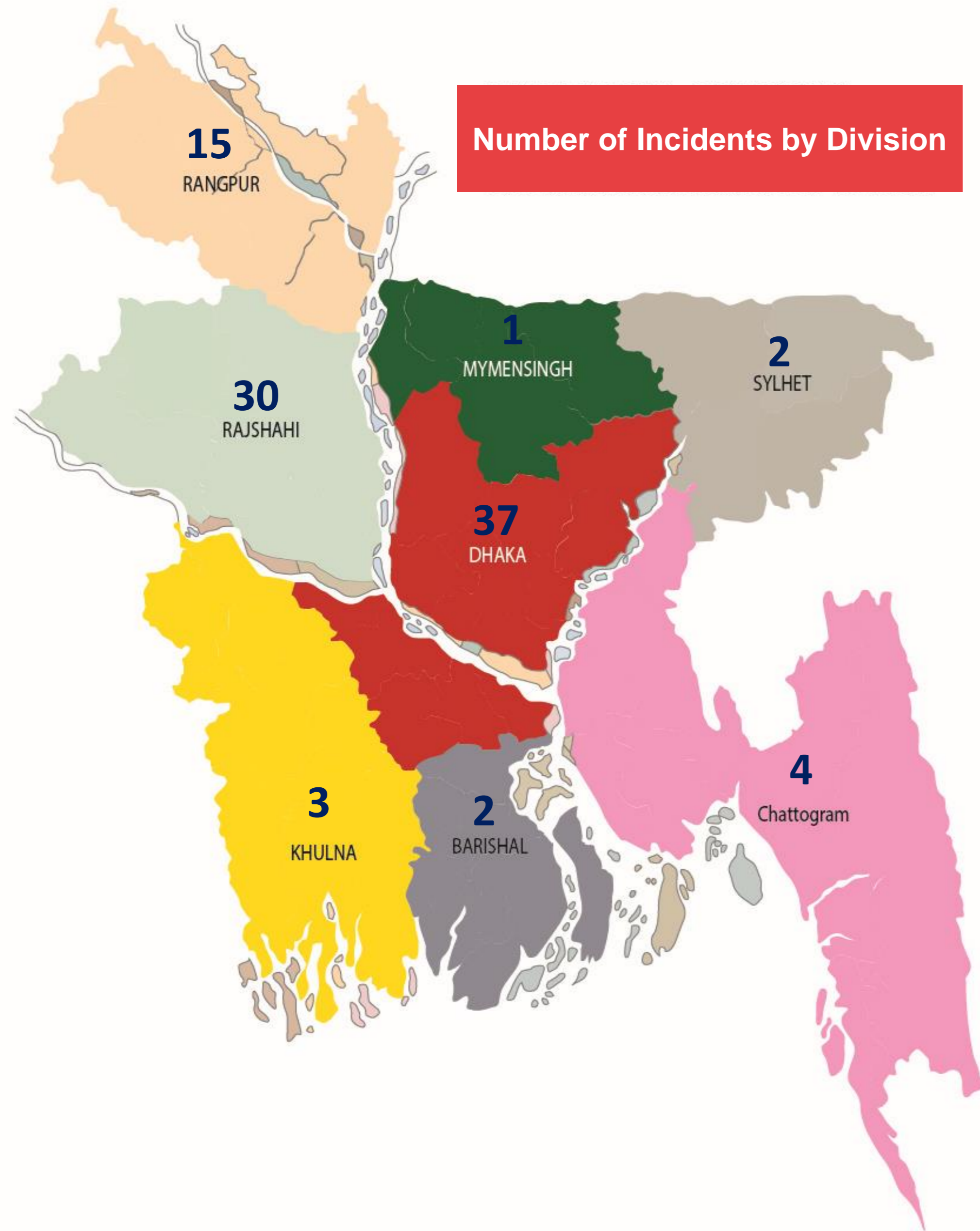

Total Number of People Arrested

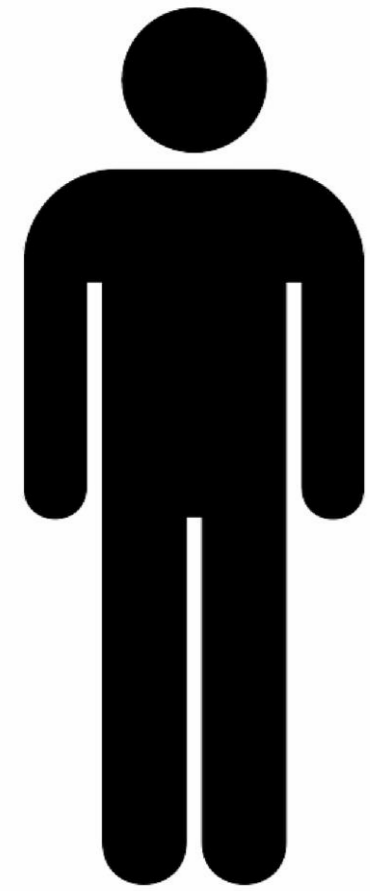


Total Number of People Killed

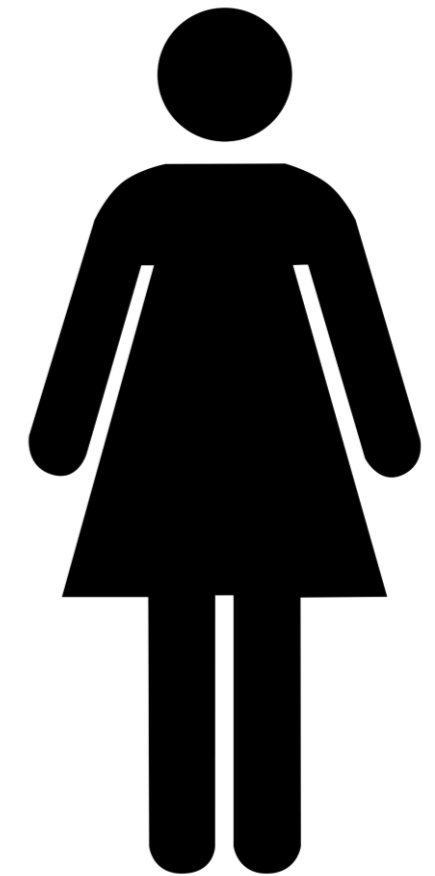


Total Number of People Injured

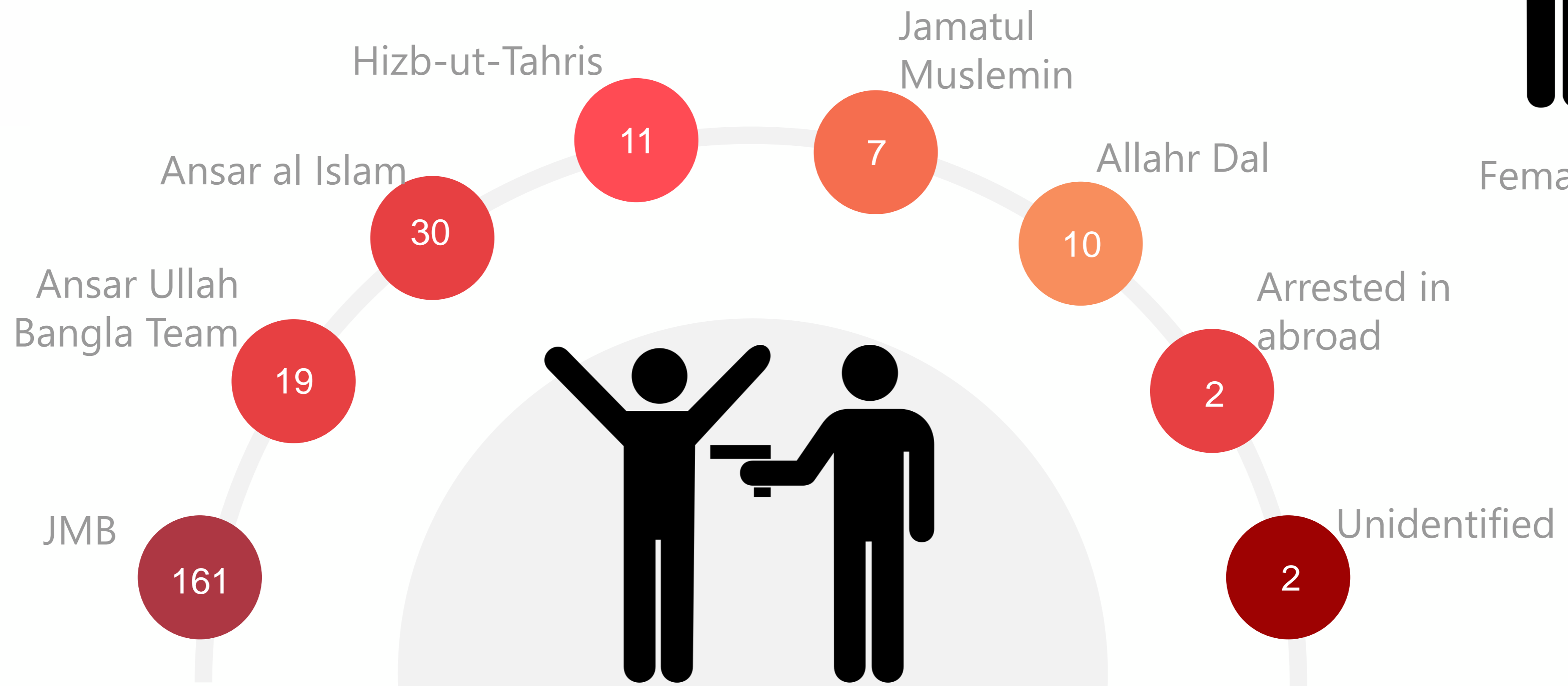
People Arrested by Different Category 2018

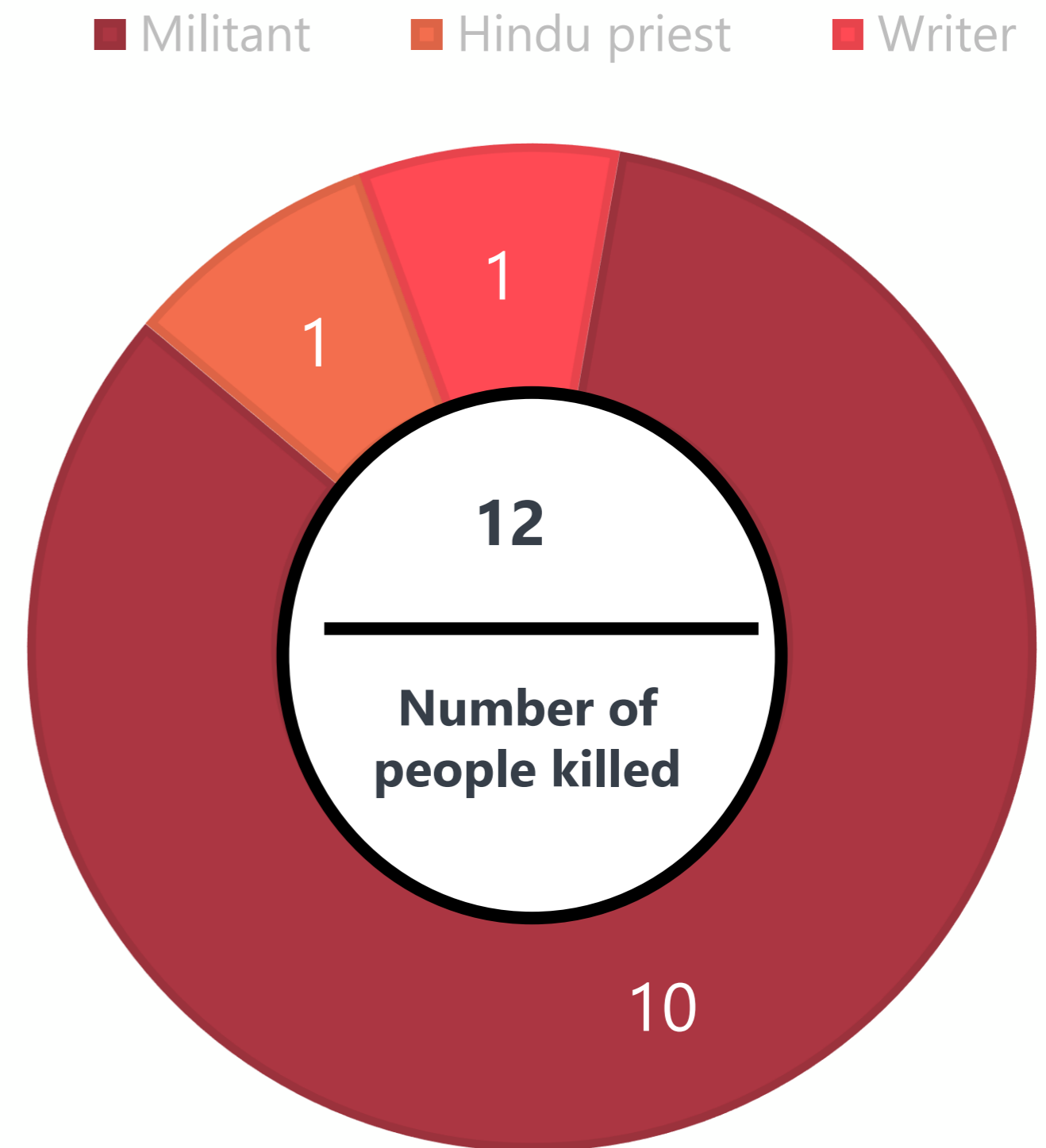


Number of people injured and killed by different category in 2018

Prosecution/Execution

- 13 March 2018 - 2 JMB men jailed for 20 years. They are Rasel Hossain alias Tamim (25), son of Younus Ali of Radhakanai village in Fulbari upazila of Mymensingh and Mofazzal Hossain (33), son of Ismail Hossain alias Abdus Sattar of Gurbari Clawkbistapur village in Atrai upazila of Naogaon. They were arrested with firearms, bullets and books on jihad on July 14, 2015.
- 18 March 2018 - A special court of Rangpur sentenced seven members of JMB to death for killing Khadem Rahmat Ali in Rangpur's Kaunia upazila on November 10, 2015. They were also fined Tk 20,000 each. They are Masud Rana alias Montri (33) Rangpur regional commander of the militant outfit, Ihsak Ali (34), Liton Mia alias Rafiq (32), Bijoy alias Ali alias Darji (30), Shakhwat Hossain alias Rahul (30), Sarwar Hossain alias Sabu alias Mizan (30), and Chandu Mia (20). - 5 April 2018 - Holey Artisan Attack: 'Neo JMB' man Hadisur Rahman Sagor admits supplying arms before a magistrate. According to police source supplies includes 1 AK-22 rifle, 22 bullets, two 7.62mm pistols and 4 hand grenades.



Prosecution/Execution

- 18 April 2018 - Narayanganj court convicted 2 cadres of JMB and sentenced them to 20 years of imprisonment each in a case filed under the Explosive Substances Act. The convicted JMB men are Saiful Islam and Mafijul Islam. The court also fined them TK 20,000 each.
- 8 May 2018 - Two militants of Jama'atul Mujahideen Bangladesh (JMB) sentenced to death and three others to life term imprisonment for killing Prof AFM Rezaul Karim Siddiquee of Rajshahi University in 2016.
- 13 May 2018 - Four female JMB members get five years' jail.
- 20 May 2018 - Sirajganj Special Tribunal 1 sentenced Md Ataulah alias Bahadur Ali (30), a member of the banned militant outfit JMB to four years of rigorous imprisonment and also fined Tk 4,000 and sentenced to another six months of imprisonment in default in a case filed under the Anti-Terrorism Act. *He is the brother-in-law of militant leader Tarikul, who died in a bomb blast in Bogura on 3 April 2016.*



Prosecution/Execution

- 8 August 2018 - The Anti-Terrorism Special Tribunal has accepted charges against eight persons in the Holey Artisan attack case and acquitted Hasnat Karim of the charges on August 8. Six of the accused were produced before the court during the hearing. They are Jahangir Alam alias Rajib Gandhi, Rashedul Islam alias Rash, Sohel Mahfuz alias Hatkata Mahfuz, Rakibul Islam Reagan, Mizanur Rahman alias Boro Mizan and Hadisur Rahman Sagor. Two others – Shariful Islam Khalid and Mamunur Rashid Ripon – are absconding. The court has issued arrest warrants for them. Police pressed charges against eight people in the case on July 23
- 3 December 2018- The formal trial of Gulshan café attack case started with the deposition of the first prosecution witness Ripon Kumar Das. Dhaka Anti-terrorism Special Tribunal Judge Md Mujibur Rahman recorded the testimony of plaintiff Ripon Kumar Das, former sub-inspector of Gulshan police station. Defence Lawyer Faruque Ahmed cross-examined Ripon Kumar Das, and fixed a date for the next hearing. The tribunal framed charges against eight suspected militants in the case on November 26, and fixed December 3 for recording the statements of witnesses. Six out of eight accused- Jahangir Alam alias Rajib Gandhi , Rakibul Hasan and Hadisur Rahman Sagor – were produced before the court during the hearing. Two other accused – Shahidul Islam Khaled and Mamunur Rashid Ripon – are on the run.

Global Peace Index

Bangladesh ranked 93rd out of 163 countries with a global score of 2.084 while in last year its position was 84th with the score of 2.035. Made improvements in 2 indicators - political stability and terrorism impact but sudden influx of 700,000 Rohingya refugees from Myanmar adversely affected the improvements and positive impact.
